KINGSPORT, Tenn. — McGavock was
forced to forfeit the third and deciding game
of the TSSAA Class AAA baseball finals here
last night, losing the state championship to Sullivan North.

The McGayock Raiders were leading 4-0 with two outs in the bottom of the fifth in-ning when the Sullivan North head coach, Mike Ritz, stopped the game and informed the umpires McGavock pitcher Larry Leaver had pitched too many innings under high

Sullivan North's Ritz, who got the pitching information from Kingsport Times-News sports writer Bill Lane who keeps the official book for the Sullivan North team, said Leaver had pitched 51/3 innings in the second game and 4% innings in the third game to constitute an 11-inning effort.

According to the Tennessee Secondary
Schools Athletic Association Handbook, the
rule (page 45, item 2-C) states: "No player
may pitch more than 10 innings on consecu-

tive days. If a player has pitched at all in any inning, the inning shall count as one full inning pitched."

Having pitched 51/3 innings in the second game, Leaver was credited with having pitched six full innings under the TSSAA rule. Therefore, when he pitched to a batter in the fifth inning of the third game on the second consecutive day, he became an ineligible player and thus brought on the forfeit.

McGavock head coach Brown's book showed Leaver had pitched only five innings in the second game, and Brown thought he had five innings left for the third game. In fact, Leaver had pitched to two batters

in the fifth inning of the second game, recording only one out. "We didn't have it on our book, but they
